# When/How to Apply

We are able to provide 'the universal 15 hours' and 'the 30 hours extended childcare', you must be eligible to receive a 30-hour code, which you will need to provide to us. You must have a valid code by the end of the month before a new term starts. You must reconfirm your eligibility every 3 months. You can apply from when your child is 2 years and 36 weeks old. See attached guidance notes/additional information.

## **General Information**

A full-time place equates to 30 hours funded, therefore there is an additional cost of £3.00 per day regardless of entitlement to supervise children over the lunchtime period which is payable by the parent/carer.
